CHECKLIST FOR PRIMARY CARE PROVIDERS AND FAMILIES WITH A CHILD THAT HAS AN ELEVATED BLOOD LEAD LEVEL

The CDC states most children with any lead in their blood have no obvious immediate symptoms. If a child may have been exposed to lead, parents should talk to their child's health care provider about getting a blood lead test. Healthcare providers and most local health departments can test for lead in the blood. Many private insurance policies cover the cost of testing for lead in the blood. The cost of blood lead testing for children enrolled in Medicaid is covered by the Centers for Medicare & Medicaid services.



The Centers for Disease Control and Prevention reports that lead-based paint hazards in children's homes are the main source of lead poisoning – particularly deteriorated paint in the form of dust. The most important treatment for a child with an elevated blood lead level (EBLL) is to remove the child from exposure to the lead hazard, which for most children means reducing lead paint-based hazards in their home.

Is your home, your building, or the childcare facility or school your children attend, being renovated, repaired, or painted? Was your home, your building, or the childcare facility or school your children under age 6 attend, built before 1978? If the answer to these questions is YES, there are a few important things you need to know about lead-based paint.

Children from low-income households and those who live in housing built before 1978 are at the greatest risk of lead exposure. Houses built before 1978, the time before the use of lead in paint was banned, and houses in low-income areas, many of which have homes built before 1978, are more likely to contain lead-based paint and have pipes, faucets, and plumbing fixtures containing lead. Also, some black and brown people are at a higher risk of lead exposure due to poor housing stock.

Lead is especially dangerous to children under six years of age. Lead can affect children's brains and developing nervous systems, causing:

- Reduced IQ and learning disabilities.
- Behavior problems.
- Loss of hearing

Even children who appear healthy can have dangerous levels of lead in their bodies.

Lead is also harmful to adults. In adults, high levels of lead can pose many dangers, including:
High blood pressure and hypertension.

Pregnant Women:

Lead can accumulate in our bodies over time, where it is stored in bones along with calcium. During pregnancy, lead is released from bones as maternal calcium and is used to help form the bones of the fetus. This is particularly true if a woman does not have enough dietary calcium. Lead can also cross the placental barrier exposing the fetus to the lead. This can result in serious effects to the mother and her developing fetus, including:

- Premature birth
- Reduced growth of the fetus



STEP #2- HOME OR CHILD-CARE FACILITIES LEAD CLEAN-UP AND HOME REPAIR GRANTS.

Lead abatement includes lead-based paint abatement activities, such as inspections, risk assessments, as well as removal. Lead abatement must be performed by educated, certified professionals with proper safety protocols to limit lead exposure. The goal is to permanently eliminate lead-based paint hazards, such as serious permanent and irreversible health damage due to lead poisoning in children. This is especially important in-home environments and in any facility with frequent visitation by children, particularly those built before 1978.

To assess your home for potential health risks or safety hazards, conduct a Healthy Homes Environmental Visual Assessment of your home. The Ohio Lead Abatement Tax Credit Program provides a state income tax credit to Ohio property owners who incur qualifying lead abatement costs in connection with an eligible dwelling. The tax credit is capped at \$10,000.00 per taxpayer and per eligible dwelling.

To qualify for the state tax credit, a property owner must be an individual taxpayer, estate, or trust. The applicant must submit an application to the Ohio Department of Health documenting that the applicant incurred lead abatement costs on an eligible dwelling during the taxable year, that the eligible dwelling was built prior to 1978, and that the dwelling has passed a clearance examination. Lead abatement costs include:

- Costs incurred for lead risk assessments conducted by an Ohio licensed lead risk assessor.
- Lead abatement projects conducted by an Ohio licensed lead abatement contractor or lead abatement project designer.
- Clearance examinations performed by an Ohio licensed lead risk assessor, lead inspector, or clearance technician; and/or
- Relocation costs incurred in the relocation of occupants of an eligible dwelling to achieve occupant protection.



Upon receipt of a completed application (See Resources), the Ohio Department of Health will review the application and issue a tax credit certificate to the eligible applicant.

1. GRANTS AND LOANS

Ohio Department of Health- HUD Lead Hazard Control Grant Program (The program assists families by testing and removing lead-based paint hazards and addressing health hazards like radon, fire hazards, and carbon monoxide).

2. LEAD SAFE CLEVELAND COALITION –

CHN Housing Partners- CHN's Lead Program provides home loans, grants, and incentives to help landlords obtain their lead safe certification. This program is offered in partnership with the Lead Safe Cleveland Coalition.

In order to qualify for financial assistance, property owners must meet our eligibility guidelines. Minimum eligibility guidelines include, but are not limited to:

- The unit must be built before 1978 and located in the City of Cleveland.
- The owner must have current rental registration issued by the City of Cleveland Department of Building and Housing.
- The owner must be current on all property taxes or have a payment plan in place.

Types of repairs:

- Lead interim control improvements, including remediation and clearance.
- Repairs include paint film stabilization (repainting), treatment to minimize friction, treatment to prevent impact, cover to prevent chewing, specialized cleaning, covering/restricting access + other sources of lead.

Types of financial assistance:

- Loans
- Grants
- Incentives

Landlord Contribution:

If you are awarded or approved for funding, a landlord contribution will be required. This contribution is applied toward the costs of your lead safe project and used in addition to the award or approved funding amount. After you complete the application, our loans and grants team will provide additional details regarding the landlord contribution expectations, amount, and timeline.

Project Expectations:

All CHN HP Lead Services projects will result in lead safe clearance. After you are awarded or approved for funding, our Construction Management team will oversee and manage your construction project and related work.

3. COMMUNITY HOUSING SOLUTIONS

At CHS, every home contributes to the strength of a neighborhood. That is why we help care for homes by providing repair assistance to those in need, creating safe, healthy and well-maintained homes in our community. This program is for qualified and income-eligible Cuyahoga County homeowners. Lead exposure presents serious health risks, especially in older homes. We work with the City of Cleveland to make homes safer through the remediation of lead.

If you believe your home may contain lead paint, please call (216) 231-5815 immediately.

Eligibility Requirements:

- Must be resident of Cuyahoga County
- Must provide proof of income.
- Property must be owner-occupied and not in foreclosure.
- The owner must live in the home for at least one year.
- Owner-occupied two-family properties are eligible for work done only in the owner-occupied unit, not the rental unit.
- Property taxes must be current or in an approved payment plan with the Cuyahoga County Treasurer

4. HEBREW FREE LOAN ASSOCIATION OF NORTHEAST OHIO (HFLA) HFLA

lends money interest free to responsible individuals in need. The maximum loan amount is \$10,000. Applicants must have verifiable income that will allow them to repay the loan and have one or more suitable guarantors for the loan. If the loan is for home repairs, work must be done by an insured and bonded contractor, and estimates must be turned in with application.

5. CUYAHOGA COUNTY BOARD OF HEALTH

The Lead Safe program enables eligible low- and-moderate income homeowners and renters in targeted suburban areas outside the City of Cleveland to make changes in their homes to provide a lead safe environment for young children.

Description: The Lead Safe program enables eligible low- and-moderate income homeowners and renters in targeted suburban areas outside the City of Cleveland to make changes in their homes to provide a lead safe environment for young children.

Eligibility: Grants are offered to income-eligible homeowners and renters with a child age 5 or younger living in the home or regularly attending day care in the home. Residents of Cleveland call 216-263-LEAD. Residents of Cleveland Heights call 216-291-4869.

Eligible Repairs: Eligible lead-contaminated home repairs include Windows, Doors, Porches, and Exterior House Repairs

7. CITY OF CLEVELAND DEPARTMENT OF COMMUNITY DEVELOPMENT- LEAD HAZARD CONTROL GRANT PROGRAM

The Lead Hazard Control (LHC) Grant Program is designed to strategically advance efforts to increase lead-safe affordable housing while eliminating the possibility of childhood lead poisoning in the City of Cleveland.

Eligibility: Residents of the City of Cleveland living in older homes with children 6 years of age or younger with low-to-moderate incomes. See link below for income requirements for tenants and homeowners. Rental property owners contribute at least \$600 per unit to the project in direct funds or in-kind work on the home to reduce hazards.

Eligible Repairs: The LHC program provides lead risk assessments, identifies lead-based paint and provides grants to control lead-based paint hazards.

Type of Funding: Qualified households eligible to participate in the program are provided with grant assistance to make needed home repairs, as well as education about childhood lead poisoning prevention.

8. CITY OF SHAKER HEIGHTS, HOUSING RESOURCES -HOME REPAIR GRANTS

Description: Home repair grants are available to owner-occupied, one- and two-family properties that fit program guidelines. City Sponsored Grant Programs: Exterior Maintenance Grant, Senior Exterior Maintenance Grant, Free Paint, Senior Emergency Safety Grant.

Eligibility: Homeowners must be owner-occupants, current on property taxes or on an approved payment plan with the Cuyahoga County Treasurer's Office and must be at or below income eligibility requirements.

Eligible Repairs: Correct exterior code violations. Senior Emergency Safety Grant covers health and safety items (\$500).

Type of Funding: Grants up to \$2,500. For Senior Emergency Safety Grant, \$500.

To borrow a HEPA vacuum:

10. HAMILTON COUNTY PUBLIC HEALTH

Funding is available to reduce lead paint hazards in homes built before 1978, as well as address healthy housing issues such as ventilation and moisture control. This program is available for low-income families who have a child under the age of 6 years old, a pregnant woman, or where a child under 6 years old spends time. There are no fees or out of pocket expenses in most cases to participate in this program. Click the arrow below for instructions on how to apply!

LOCATION REQUIREMENTS

Eligible applicants must live in Hamilton County, excluding the cities of Cincinnati, Norwood, and Springdale.

Pre-Screening Eligibility Requirements:

- The home is a single family or multi-family property (4 units or less) built before 1978.
- The property must have one or more bedrooms per unit (No efficiency apartments).
- Residents must be at or below 80% of the area median income (AMI).
- The household must include either a child under the age of 6, a pregnant woman, or have a child under the age of 6 that regularly visits the home for 6 or more hours per week.
- Priority will be given to homes occupied by a child under the age of 6 whose blood lead level is 5 µg/dL or greater.
- The home can be owner occupied or rental housing.
- Property taxes and mortgage payments (if applicable) must be current.
- Utilities including water and electricity must be on and available

Post Lead Hazard Reduction Requirements:

- To be eligible for this grant, owner-occupied units must keep the property as their primary residence for 3 years after work is completed.
- Owners of rental units must make units available to low-income families, with priority given to renters with children under six, for 3 years after work is completed.

12. Community Housing Impact and Preservation Program (CHIP) Columbiana County Commissioners/Columbiana County Community Action Agency

Description: Housing Rehabilitation Assistance and Home Repair Assistance

Eligibility: Owner-occupied homeowners. Income and other eligibility criteria apply.

Eligible Repairs: Rehabilitation: Installation and/or repairs to foundations, roofs, gutters electrical upgrades, plumbing, furnaces, hot water heaters, insulation, windows, doors, accessibility improvements and lead based paint reduction. Home repair: roofs, handicapped accessibility, water taps, septic repairs or replacements, foundation repairs, electrical repairs, plumbing repairs, window replacement, new roofs, new furnaces, insulation, siding repair and lead based paint reduction.

13. OHIO DEPARTMENT OF HEALTH THROUGH A GRANT FROM HUD LEAD HAZARD CONTROL GRANT

Description: Lead hazard control program for homeowners and tenant households. Households must have low-to-moderate incomes and lead in their unit. Program assists homeowner directly; tenants are assisted by a grant to their landlord.

Eligibility: Household income cannot exceed 80% of area median income. If the property is owner occupied, either a child under 6 years of age must live in the home or visit a significant amount of time, or there must be a pregnant woman living in the home. If the home is a rental, the owner must agree to not significantly raise the rent for a 3-year period and the owner must make a good faith effort to rent to low income families with children. Structures with more than 4 units are not eligible for assistance.

Eligible Repairs: Lead hazard control repairs

14. USDA RURAL DEVELOPMENT -VERY LOW-INCOME HOUSING REPAIR PROGRAM

Description: Provides loans and grants to very low-income homeowners to repair, improve, or modernize their home.

Eligibility Loans: Homeowner must be unable to obtain affordable credit elsewhere and have very low incomes, defined as below 50 percent of the area median income. Maximum loan is \$20,000.

Eligibility Grants: Homeowners who are 62 years old or older and cannot repay a Section 504 Loan. Maximum grant is \$7,500.

Eligible Repairs: Loans may be used to repair, improve, or modernize homes or remove health and safety hazards. Grants must be used to remove health and safety hazards.
